The need for a dedicated federal financial commitment to the country's infrastructure is more critical than ever, according to the **Long Island Contractors' Association (LICA) Executive Director Marc Herbst**. Following the President's address to a joint session of Congress, Herbst observed, "It's been two years since Washington failed to adopt a new federal surface transportation funding program after the expiration of the existing plan (SAFETEA-LU). Since then, Congress has enacted short-term extensions, which only destabilized America's infrastructure and the construction industry tasked with building it."

The Long Island heavy construction industry has endured unprecedented 30 percent unemployment levels since SAFETEA-LU was allowed to sunset in 2009.

'ETTING BEYOND THE RHETORIC

"If the President is serious about job creation, he should propose a robust transportation plan that goes above and beyond current proposals now before Congress," asserted Herbst. The House of Representatives has a highway and transit plan offered by **Representative John Mica (R – FL)** that proposes about a \$35 billion average annual investment for six years. That appropriation is approximately \$18 billion below current annual levels. If adopted, New York State would suffer a loss of nearly 45,000 jobs. The Senate proposal, sponsored by **Senator Barbara Boxer (D – CA)**, would sustain the present investment levels at \$54 billion, but for only the next two years.

"An infrastructure investment bank is an excellent funding tool but to offer such a proposal before addressing the federal government's transportation long-term funding program is a distraction to the nation's true infrastructure needs," reminded Herbst.

"The quality of our highways, roads, bridges, mass transportation systems, and infrastructure ensuring clean water and proper management of wastewater will determine the fate of our economy and the ability to create jobs and generate new investment," added **LICA Chairman James Pratt, III**. "The ARRA program was publicly perceived incorrectly as a construction jobs program at the onset, only to prove otherwise. An infrastructure bank proposal will elicit a similar reaction."

EXPANSION AND RENOVATION



The Long Island Contractors' Association (LICA) is proud to recognize a significant reconstruction project taking place on Long Island that has very little, if anything, to do with our local roadways, bridges, tunnels or sewer systems – the expansion of **Calverton National Cemetery** in Riverhead, which serves as a final resting place for thousands of American servicemen and women and their families.

LICA member **Pratt Brothers, Inc.** is performing this vital renovation on the cemetery, helping create an environment that allows for quiet reflection and tribute to those who served our country. The **Department of Veterans Affairs (VA)** awarded

GC&P Fab-Con, LLC, which is a joint venture company consisting of **G&C Fab-Con, LLC** and Pratt Brothers, Inc., a \$32.2 million contract to perform the work.

EXPANSION AND RENOVATION

Improvements for Calverton National Cemetery involve development of a 90-acre gravesite expansion area including clearing, earthwork, installation of 33,000 precast concrete burial crypts, drainage, asphalt roadways, irrigation wells, centrally controlled irrigation system and landscaping.

“Calverton National Cemetery is the largest by area in the country, at 1000 acres, and is considered one of the crown jewels of the national cemetery system,” said **Ed McCoy of Pratt Brothers, Inc.** “As such, we are held to very high standards across the board from construction operations, manpower, and finished product.”

Also included in the project are improvements to the existing cemetery, such as rehabilitation of the existing committal shelters; construction of new columbarium niches; all new curbs and walkways; rehabbing the existing roadways and re-paving; replacing existing trash cans, vase holders and lawn

hydrants; renovations to the existing maintenance building and administration building; reconstruction of the cemetery main entranceway; including decorative stamped and colored concrete; and granite renovations.

Construction, which began in September of 2009, is expected to be completed this fall, prior to Veteran's Day.

In the wake of a series of severe storms that have pummeled the northeast, the **New York State Department of Transportation (NYSDOT)** is soliciting proposals that cover a broad range of requirements, including construction contracts, engineering consultant contracts and related professional consultant contracts and/or contracts for commodities and services. NYSDOT may also be soliciting proposals for design-build contracts.

The Governor's Executive Order 19 has suspended many of the usual contracting and procurement requirements for this emergency, including the requirement for advertisement in the New York State Contract Reporter. Therefore, all parties interested in performing emergency response work for NYSDOT should closely monitor the NYSDOT website at www.nysdot.gov/business. Contract opportunities and related information will be posted on this website as soon as they are available. These may include notice of pre-solicitation informational meetings, Q&A sessions and/or opportunities for site visits.

There will be one or more emergency job bids posted by the end of this week, beginning of next week at the latest, for restoration of damaged infrastructure in upstate counties including Albany, Delaware, Greene, Rensselaer, and Schoharie. These will be “best value” procurement bids, based on past performance, cost and time tables.

Additionally, there will be two-project-specific emergency bids. The first project, the Route 32 Bridge in Greene County, is also “best value,” with construction completion by the end of October. The bid documents should be available by the end of this week.

The second project is for the Route 42 Bridge, also in Greene County. This project will be design-build, managed by **Parsons Brinkerhoff**. Also a “best value” bid, a site meeting will be held for interested contractors at the end of this week.

A Request for Proposals (RFP) should be issued within two weeks.

New York State Transportation Commissioner Joan McDonald also asked that LICA convey **Governor Andrew Cuomo's** appreciation and thanks for the outstanding response our industry has already provided in response to the need for emergency assistance.

McDonald praised the industry's response to date, observing, "(We have) painted a positive picture of what our industry is capable of doing in response to an emergency situation and what can be performed unrestrained in normal situations."
